Darren addressed that the Government had lifted restrictions and Tennis Queensland had released Stage 2 be active from today.

Myleigh discussed the requirements from Tennis Queensland's Stage 2 return to play and level B community Guidelines.

Nick would like to resume Hotshots play as of Wednesday 10th he will implement 16 max players (4 per court, 1 umpiring) they will remain on allocated court during duration. Parents are to drop child off and remain in car. He will have Logan helping who will complete the Covid-19 training and be under Nick's supervision and instruction. He is not implementing group lessons at this stage due to restrictions on numbers per court. He will also implement Cardio Tennis on Wednesday 10th. He will be abiding by requirements and enforcing social distancing and hygiene methods.

As our season is almost at an end it was decided to not return to competition however Lisa will supervise a Monday & Thursday social play for her regular fixture players, Darren will supervise Wednesday social play evenings.

Again these will still fall under regulated numbers. This will cost \$6 per player to be paid via eftpos (no surcharge applies) 2nd hand balls from previous fixtures prior to Covid-19 will be used during this play and when play is finished returned to used bucket where they can be sterilised before the next weeks play.

Lisa will return her social Tennis group play on Tuesday evenings with no more than 10 per court as required by Industry.

Competitions will return as normal from Term 3 in guidance with stage 2 or possibly 3 if implemented

Hire will remain how it is currently and not available during any organised tennis for e.g. U3A

U3A may proceed however it was agreed that as it is supervised by a non-committee member and the group is high risk that we will keep the capacity at 10 people. Tex who is supervisor will have to complete the Covid-19 training and checklist/record of play

Clubhouse will remain closed and only available for toilet breaks. The supervisors will be responsible for completing play checklist, and completing clean at end of activity.
